SUBJECT: SROG ANNUAL YEAR-END FLOW AND LOADING REPORT FOR FISCAL YEAR 2023-24

As stated in the Year End Flow and Loading Report, the objectives of this report are to:

- 1. Determine the total wastewater flow and loading treated at the 91st Avenue WWTP.
- 2. Identify the most representative annual average daily flow (MGD) for each SROG city.
- 3. Identify the most representative annual average daily chemical oxygen demand and total suspended solids loadings for each SROG city.

This report is used to validate the actual flows and loadings each SROG city sends to the 91st Avenue WWTP. Throughout the fiscal year each city is billed monthly based on flows and strengths that were estimated at the beginning of the year. This report, after being reviewed and approved by each SROG city, constitutes the actual flows and strengths for the fiscal year and is used in the determination for the final charges for each city. This adjustment to actual is produced in a schedule entitled "SROG Year-End Settlement," which is created by the City of Phoenix and audited by the SROG auditors.

SUBJECT: AUTHORIZATION TO EXECUTE A CONTRACT WITH HAZEN AND SAWYER

This request would authorize the City of Phoenix to execute a contract with Hazen and Sawyer for \$300,000, of which \$80,000 is attributable to SROG, for the purpose of providing professional support services related to whole effluent toxicity testing, toxicity identification evaluation for wastewater treatment and water reclamation facilities to meet and stay in compliance with conditions and requirements of the National Pollutant Discharge Elimination Standards (NPDES) and Arizona Pollutant Discharge Elimination Standards (AZPDES) permits.

Toxicity Identification Evaluation (TIE) testing and analysis is a provision in the NPDES and AZPDES permits. Hazen and Sawyer will begin by updating the city's current TIE work plan. After updating the work plan, this contract will provide on-call technical support services on an as-needed basis. It is necessary to retain a consultant for this work because if toxicity were discovered, an immediate response of accelerated testing would need to be initiated according to the provisions of the permit. The consultants must be available immediately, when needed, and will be responsible for the implementation of accelerated testing procedures as required; provide possible lab services to conduct WET testing and analysis; perform TIE and toxicity source investigation; perform toxicity identification potential control methods; provide written reports of all investigations, findings and recommendations; participate in meetings and discussions with regulatory agencies; and, perform process and regulatory impact analysis of changes of facility and operation.

The contract is for a five year period.

RECOMMENDATION

At their August 15, 2024 meeting, the SROG Advisory Committee recommended that:

the SROG Committee authorize the City of Phoenix to enter into a contract with Hazen and Sawyer for an amount Not to Exceed \$80,000 for support services related to toxicity identification evaluation services for the 91st Avenue WWTP. Funds for these services are available in the SROG CIP Cash Flow for Fiscal Years 2024-2025 in WS90100103, using Billing Schedule 56.

A. Call to Order

Ms. Kisling called the meeting to order at 1:31 p.m.

B. General Business – Items for Discussion and Possible Action

1. The next SROG Advisory Committee meeting was scheduled for Thursday, September 19, 2024, 1:30 p.m

2. <u>Information Items</u>

There were no comments on the information items.

3. 91st Avenue WWTP Year End Flow and Loading Report for Fiscal Year 2023-24

Mr. Todd of Wilson Engineers presented the Fiscal Year 2023-2024 Year End Flow and Loading Report. Mr. Todd presented this report to the SROG SPEC Committee on August 8, 2024.

Mr. Todd stated that the overall flow to 91st Avenue averaged 153.23 mgd, which is higher than it has been.

Mr. Todd stated the most notable city was Phoenix, whose flows were higher than projected. This is primarily due to operations from 23rd Avenue. The RID did not take as much flow as usual, so the flows were put back in the SRO and sent to 91st Ave. As the flows were treated at 23rd Ave, the flows did not have a lot of loading. The cities of Glendale, Scottsdale and Tempe were slightly below the previous fiscal year, with Mesa and Phoenix slightly higher. Mr. Todd stated that the COD loading was higher than projected for Glendale and Tempe, with all cities except Phoenix being slightly higher than last fiscal year. Regarding TSS, Tempe was the only city above projections.

Mr. Draper asked if the lower loadings from Phoenix were due to the flows from 23rd Ave. Mr. Todd responded that is part of the reason, as well as Phoenix being pretty conservative with their projections.

Upon a motion by Ms. Kisling, a second by Mr. Draper and unanimous approval, the SROG Advisory Committee recommend to the SROG Committee that the Year End Flow and Loading Numbers for Fiscal Year 2023-24 be accepted as prepared and presented by Wilson Engineers.

4. Request to Enter Contract, WS90100103 – Toxicity Identification Evaluation

Ms. Gonzales stated that the City of Phoenix is requesting authorization to enter a contract with Hazen and Sawyer for an amount not to exceed \$80,000 for support services related to toxicity identification evaluation. Ms. Gonzales explained that these funds are only used when needed, and that it renews every five years.

Hazen and Sawyer was the firm selected by the SROG panel on May 28, 2024. It was advertised as a joint contract for both the 23rd and 91st Avenue facilities, and 23rd Avenue will be paying \$220,000. Ms. Gonzales said we have not used this contract in a while, but recently started using it for gross beta exceedances.

Upon a motion by Ms. Kisling, a second by Mr.Roye and unanimous approval, the SROG Advisory Committee recommended to the SROG Committee that the City of Phoenix be authorized to execute a contract with Hazen and Sawyer for an amount not to exceed \$80,000 for support services related to toxicity identification evaluation services for the 91st Avenue WWTP. Funds for these services are available in the SROG CIP Cash Flow for Fiscal Years 2024-2025 in WS90100103, using Billing Schedule 56.

- 5. Request to Advertise WS90100117 Solids Rehab Phase 2 Design and CA&I
- 6. Request to Advertise WS90100117 Solids Rehab Phase 2 CMAR

As items 5 and 6 are for the same project, Mr. Masche discussed them together and the project as a whole. Mr. Masche stated that in 2004-2005, we started doing digester dome replacements at 91st Ave using JOC contracts. In 2018 we did a CMAR contract with the

intention of replacing the last 4 domes that needed replacing and be done. Then there were contract delays, operational issues and then the pandemic which all messed up the schedule. As a result the CMAR contract is due to expire in September of 2025 with no possibility of an extension. There are two digesters leftadd that need domes replaced, those are digesters 3 and 4. The domes are original from the late 1960's construction.

Mr. Masche pointed out that digesters 13, 14 and 15 were constructed in 1986 and 1997, and at some point down the road they will need to be replaced.

This contract will be a combination of the digester domes and the work that was deferred from solids phase one. It was determined that due to rising costs and priorities that some of the work would be deferred. That work is now being addressed in this contract.

Upon a motion by Ms. Kisling, a second by Mr. Caggiano and unanimous approval, the SROG Advisory Committee authorized the City of Phoenix to advertise, select a consultant, and negotiate scope of work and fee for professional services for an amount not to exceed \$8,000,000 to provide professional consultant services for design, and CA&I services related to the 91st Avenue Solids Rehabilitation Phase 2 Project. Funds for these services will be budgeted WS90100117 in the SROG CIP Cash Flow beginning Fiscal Year 2025-26. Project Number WS901001117 will be billed per Billing Schedule 56 (6.45% Glendale, 14.29% Mesa, 55.16% Phoenix, and 9.9% Scottsdale, and 14.20% Tempe)

Upon a motion by Ms. Kisling, a second by Mr. Rose and unanimous approval, the SROG Advisory Committee authorized the City of Phoenix to advertise, select and negotiate scope of work and fee for an amount not to exceed \$45,000,000 to provide Preconstruction and Construction Services by the Construction Manager at Risk related to the Solids Rehabilitation Phase 2. Funds for these services will be budgeted WS90100117 in the SROG CIP Cash Flow beginning Fiscal Year 2025-26. Project Number WS901001117 will be billed per Billing Schedule 56 (6.45% Glendale, 14.29% Mesa, 55.16% Phoenix, and 9.9% Scottsdale, and 14.20% Tempe)
